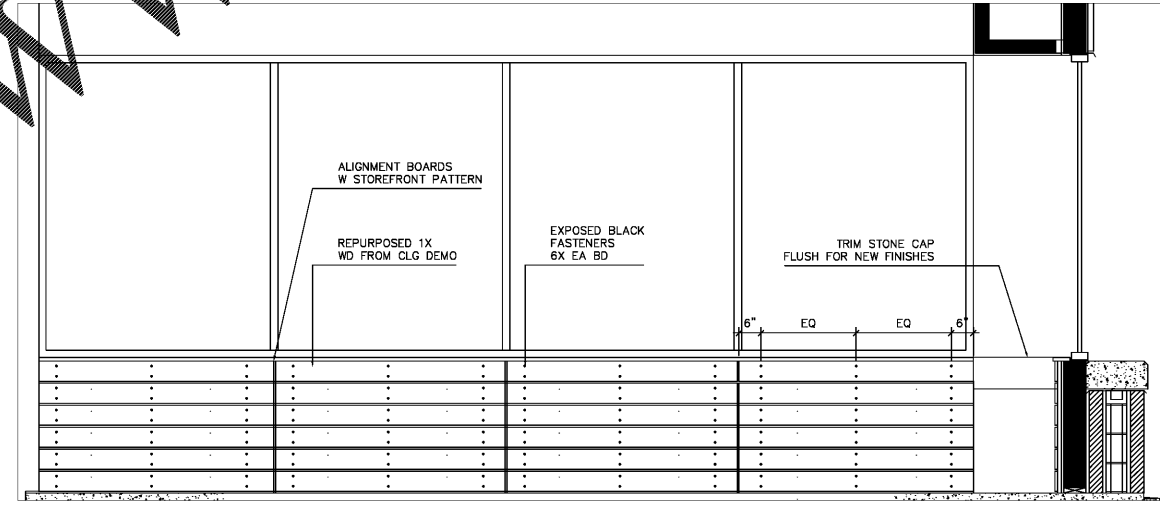
### SPECIFICATIONS

- Floor  
 1. Existing floor finish to remain. Coordinate new partitions and finishes as required.
- Walls
- Interior  
 1. New interior partitions to be 3-5/8" metal stud 20 gage, brace at 48" oc max. All components to be from single source manufacturer. Provide 5/8" GWB each side.  
 2. Provide GWB trim and finish components as required-no exposed ends/edges.
- Exterior  
 1. New Exterior studs to be 6" metal stud 18 gage (match existing structure) brace at 48" oc max. Provide 5/8" FRT plywood below store front windows. Provide 5/8" GWB on interior side above storefront windows. Provide 5/8" Dens-Gement on exterior side.  
 2. Provide R19 batt insulation inside 6" stud wall at all exterior locations. Seal tight to structure.  
 3. Provide 1" continuous rigid polystyrene insulation on exterior side of exterior stud wall.  
 4. Prime/paint any exposed interior.  
 5. Provide steel jamb/header liners for overhead door locations.



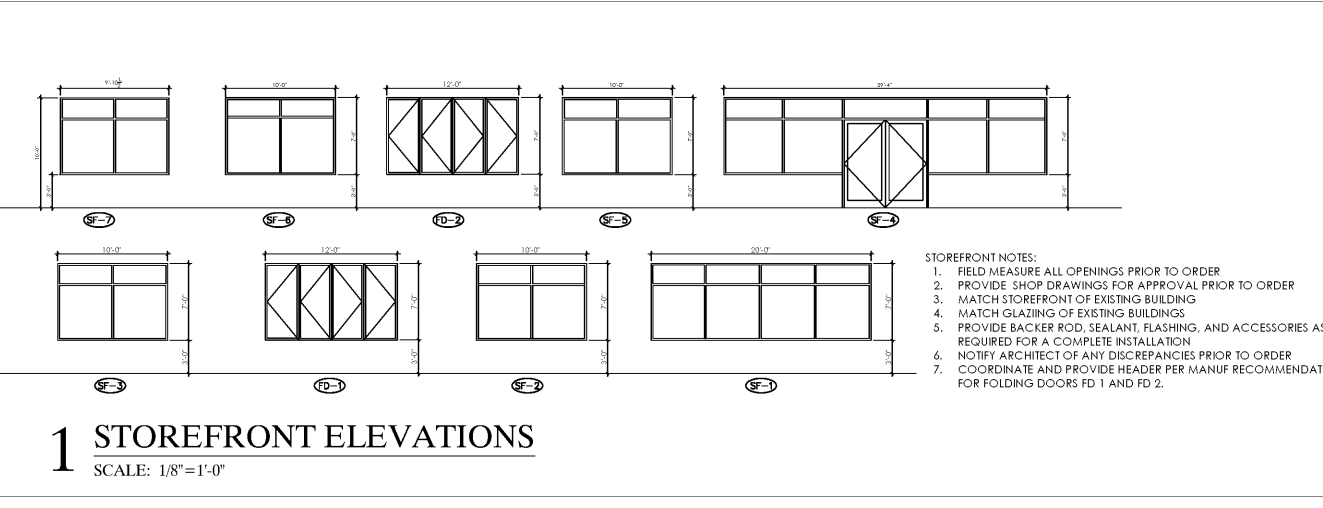
### Storefront

1. Provide storefront system to match existing building and finish in locations shown per drawings.
  2. Match existing building hardware, locks, and key system in new work.
- Glazing  
 Provide IGU's to match existing building to match existing building in color/performance.
- Overhead doors  
 1. Overhead doors to be ThermoCore 521 Aluminum full view insulated w Solarban 70 XL glazing  
 2. Match store front colors  
 3. Provide openers/motors and associated controls  
 4. Provide head/sill flashing  
 5. Provide painted steel jamb/header liner channels.
- Ceiling  
 1. Provide R20 insulation attached to the underside of the existing metal deck-cover w black scrim.  
 2. All exposed structure and ceiling elements to be primed/painted.  
 3. Paint exposed overhead door track/hardware to match ceiling.
- Lights  
 1. Existing wall mounted lights to remain.

 5. PROVIDE BACKER ROD, SEALANT, FLASHING, AND ACCESSORIES AS REQUIRED FOR A COMPLETE INSTALLATION  
 6. NOTIFY ARCHITECT OF ANY DISCREPANCIES PRIOR TO ORDER  
 7. COORDINATE AND PROVIDE HEADER PER MANUF RECOMMENDATION FOR FOLDING DOORS FD 1 AND FD 2.
